Matches will be: best 2 out of 3 games to 11 points and win by 2; round robins win by 1; or matches to 15 or 21 points, win by 2. Losers must referee the next match or find a referee to do so. . Balls will be provided. You must bring your own regulation paddle. USAPA rules will govern play. The yellow seamless ball will be the official tournament ball. Players must be on the board when their matches are called. A 15-minute delay will result in forfeiture.

Prior to participating as an athlete I will inspect the facilities and equipment to be used and if I believe same to be unsafe, I will immediately report such conditions to the Sport Commissioner, Supervisor or Official connected with the Games of same and either decline to participate or assume the risk of participating.

The undersigned expressly agrees that the foregoing Waiver and Release of all claims is intended to be as broad and inclusive as is permitted by the laws of California and that if any portion thereof is held invalid it is agreed that the balance shall not withstanding, continue in full legal force and effect.
