This tournament will be double elimination. This offers all participants at least two matches. Matches will be 2 out of 3 games in the winner's bracket, and one game to fifteen in the loser's bracket. Tournament pairings will be established by a random draw.

DEADLINE: Entry forms must be received by January 8, 2011.

This is a USAPA Sanctioned (Tier 4) Tournament that will feature four age groups, in mixed doubles, and men's and women's doubles. The age groups are 50-59, 60-64, 65-69, and 70+. Your team's age group is determined by the age of the youngest partner on 12-31-11.

We will play this day until there are four teams left in each age group. Those 4 teams will come back the next day (January 13th) at 8:30 am to play for the medals.

January 14th 8:15 am start of men's and women's doubles 50-59
9:00 am start of men's and women's doubles 60-64
11:30 am start of men's and women's doubles 70+
12:30 pm start of men's and women's doubles 65-69

We will play this day until there are four teams left in each age group. The final four teams in each division will come back on January 15th at 8:30 am to play for the medals

YOU MUST CHECK IN AT LEAST 15 MINUTES PRIOR TO YOUR START TIME

We will reserve January 16th as a rain date, and play that day only if needed.

Tournament organizers may move one or two age groups to the Stonecrest Pickleball Courts, in the event of rain or large turnout. The committee also reserves the right to separate the age divisions if enough entries are received, especially in the 50-54 age group.

A viewing area adjacent to the courts will be prepared for spectators. Bring your chairs if desired. If weather permits, we will remove some of the windscreens around the courts to maximize viewing pleasure. There will be drinks and snacks available for spectators to purchase.

AGREEMENT * RELEASE AND WAIVER OF LIABILITY

In consideration of being permitted to participate in the Pickleball Geezer Meister qualifier being held at Del Webb Spruce Creek, I the undersigned DO HEREBY:

1. RELEASE, WAIVE, FOREVER DISCHARGE, HOLD HARMLESS, AND COVENANT NOT TO SUE THE DEL WEBB SPRUCE CREEK HOA AND PICKLEBALL CLUB.)
2. INDEMNIFY AND HOLD HARMLESS: Release from and against any loss, liability, damage or cost that I or any of my guests may incur due to participation, involvement or presence of Pickleball, whether caused by negligence, action or inaction of Release or otherwise.
1. ASSUME FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or in any way connected with the participation, involvement in or presence by me and my guests at Pickleball suffered before, during or after Pickleball, whether caused by the negligence, action or inaction of Releases or otherwise. I understand that participation, involvement or presence at Pickleball carries the risk of injury or death or property damage and I accept that risk freely and voluntarily.
2. AGREE that the forgoing release, waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by Florida law, and that if any portion is held invalid for any reason, the balance should notwithstanding, continue in full legal force and effect
